WAIVER, RELEASE AND HOLD HARMLESS AGREEMENT

In consideration for my participation as Cast to the 14th Factory Documentary, which is managed and produced by The Fourteenth Factory NPO and Drive Studios, LLC (the "Company"), I, the undersigned, hereby agree for myself and for my personal representatives, heirs, next of kin, successors, and assigns:

1. To release, waive and discharge the Company, its boards, agents, employees, representatives, contractors or subcontractors, or their employees (hereinafter, "Released Parties") from any and all claims or demands of any kind and from all liability, penalties, costs, losses, damages, expenses, claims, or judgments (including attorneys' fees) resulting from injury, death, or damage to any patron, visitor, third parties or property of any kind, which injury, death or damage arises out of or is in any way connected directly or indirectly to my purchase, whether caused by Released Parties' active or passive negligence or otherwise. I understand that this release extends to claims that I do not know or do not expect to exist at the time of the signing of this release, and I hereby waive the protections of California Civil Code section 1542.

This indemnity shall include, without limitation, reasonable attorneys', experts' and consultants' fees, investigative costs, and all other reasonable costs incurred by Released Parties.
3. To assume full responsibility for and risk of bodily injury or property damage incurred by myself arising either directly or indirectly from my purchase, from any cause whatsoever, whether caused by Released Parties' active or passive negligence or otherwise.

That the Released Parties shall not be liable for any damage to any property owned by me, or my agents, employees, contractors or subcontractors, or their employees, or for any bodily injury or death to such persons, resulting or arising from the condition of the Premises, all improvements and/or structures located on the Premises or its use by me.
